STANDARDISED PRICE LIST

All funeral directors are legally required to publish this Price List for a standardised set of products and services. This is to help you think through your options and make choices, and to let you compare prices between different funeral directors (because prices can vary).

ATTENDED FUNERAL (funeral director's charges only)

£2,695

This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.

- Taking care of all necessary legal and administrative arrangements **£725**
- Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care **£265**
- Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at both the funeral director's branch premises and at other non-branch premises. **£1,025**
- Providing a suitable coffin – this will be made from wood effect veneer **£250**
- Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer) **£5**
- At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle **£425**

UNATTENDED FUNERAL

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

- **Burial** (funeral director's charges only) **Not Offered**
- **Cremation** (funeral director's charges plus the cremation fee)² **£1,545**

FEES YOU MUST PAY

- For an Attended or Unattended burial funeral, **the burial fee.**¹
In this local area, the typical cost of the burial fee for local residents is:
For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees. **£1,115**
- For an Attended cremation funeral, **the cremation fee.**²
In this local area, the typical cost of a cremation for local residents is: **£1080 - £1295**

ADDITIONAL FUNERAL DIRECTOR PRODUCTS AND SERVICES

This funeral director may be able to supply a range of optional, additional products and services, or to arrange (on your behalf) for a third party to supply them. Examples include:

- Additional mileage (price per mile) **£2.25**
- Additional transfers of the deceased person's body (e.g. to their home, to a place of worship etc.) (price per transfer) **£225**
- Collection and delivery of ashes **£0**
- Embalming* **£225**
- Funeral officiant (e.g. celebrant, minister of religion etc.) **Prices on request**
- Services supplied outside of normal office hours **Prices on request**

The funeral director can give you a full list of what they can supply. They are likely to charge for these additional products and services, so you may choose to take care of some arrangements without their involvement, or you can use a different supplier.

1. This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or for reopening and closing an existing grave.

2. In Northern Ireland, you will usually need to pay doctors' fees as well. This charge is for a doctor to sign the Medical Certificate for Cremation.

TERMS OF BUSINESS

Please find below standard terms of business for our funerals.
If you have any questions, please ask your funeral director.

We require a valid proof of address, such as a driving licence or recent utility bill, in order to process any invoice payable after the funeral. If this is not available, payment in full must be made at the time of arrangement.

UNATTENDED FUNERAL or any of our services with an unattended cremation (as detailed on the funeral service documentation).

INITIAL PAYMENT REQUIRED

FULL PAYMENT REQUIRED

Full payment required within 48 hours
prior to the date of the funeral

ATTENDED FUNERAL

INITIAL PAYMENT REQUIRED

AMOUNT Initial payment must cover 100% of the value of all External Payments (made on your behalf) + 75% of Our Charges. This amount will be provided to you at the point of arrangement.

WHEN 48 hours prior to the date of the funeral

FULL PAYMENT REQUIRED

Remaining balance due within 21 days
after the date of the funeral

These terms of business apply to the majority of funerals we provide. There may be occasions when we need to take full payment from you on the day of the arrangement. This will depend upon individual circumstances and/or the nature of the services being provided. If this applies, we will notify you either at the time of signing the Agreement with us or as soon as possible prior to the service taking place.

PAYMENT OPTIONS

Cash, cheque, debit or credit card or bank transfer.

DWP (DEPARTMENT FOR WORK AND PENSIONS)

If you have made or intend to make an application for a DWP Funeral Payment or any other financial assistance or grant to help you pay for the funeral, it is likely that it will only cover part of the Funeral Cost that you owe us. In some cases, an application for a DWP Funeral Payment or any other financial assistance or grant may not be successful or only be partly successful. It is important to remember that in all these circumstances you will still be responsible to us for payment of any outstanding money in relation to the Funeral Cost. If you have, or intend to make an application for financial assistance you must tell us prior to the funeral.

CREDIT CHECKS

We may carry out credit checks on you, whether before or after entering into an Agreement. By signing our Agreement, you give us consent to process your personal data and provide it to third parties in order to carry out the credit checks. Depending on the outcome of those credit checks, we may insist upon full payment in advance.

LATE PAYMENT

If you (or the person you are expecting to pay) does not make full payment due to us by the due date for payment, we may charge interest to you on the overdue amount at the rate of 4% a year above the Bank of England base rate from time to time, plus reimbursement costs of any expenses made by us, unless we have agreed alternative arrangements with you.

This level of interest will be charged from the date on which payment was due until the date on which it is repaid in full and you must pay us interest together with any overdue amount.

Please note that if the invoice remains outstanding after 60 days of delivery, we may ask another company to collect or receive outstanding payments on our behalf.

However, if you dispute an invoice in good faith and contact us to let us know promptly after you have received an invoice that you dispute it, we will not charge you interest or transfer your debt to another company until we have investigated the dispute.
